### Pasco County Housing Authority:

**Coalition for the Homeless of Pasco County:** Showers and offices are closed to clients. Clients are encouraged to call office for resources and information at 727-842-8605. inspections are limited, unless it's an emergency.

**Samaritan Project:** Office is still open for appointments and focusing on outreach- providing tents, food, water, etc. Please call the office, 813-810-8670, and leave a message if necessary to reach someone to take your information.

**Career Source:** Offices are closed but working remotely. Staff can be reached through the 'live chat' feature on the website.

**ROPE Center:** No new intakes at this time and COR Center is closed for services.

### Pasco County Public Transportation:

- Suspending all fares until further notice. Fare-free ridership assists customers who might be experiencing financial hardship as a result of COVID-19 related closures.
- PCPT is limiting the number of riders allowed on each bus to 10 to 15 riders at a time. PCPT will increase the number of buses on the busiest routes by reassigning them from under-used routes
- Temporary suspension of service on Routes 18, 25, 31 & 41.
